- 1 COMMISIONER HOFMAN: Well, that makes it more
- interesting because there's -- there's rules, which I
- spoke to, but there's also intent. And I'm weighing
- 4 carefully the intent and what the future holds, and I'm
- 5 just wondering if -- if there is enforcement
- 6 proceedings; if they're going on, and it's going to be
- 7 removed or they're not. It's a tough one. So I'm going
- 8 to defer to listen to the rest of the comments from the
- 9 commission.
- But I will tell you one thing I did want to
- 11 mention with one of the withdrawn items -- it was the
- 12 National Avenue one, and I don't want the same thing to
- 13 happen here -- is I had real problems with that
- 14 recommendation. I was going to support the appeal based
- on a high school being within a 1,000 feet because it
- 16 was considered in the staff report that a barrier were
- school -- were just buildings and private fences, which
- is a long stretch from a barrier like a freeway or a
- 19 flood control or a hillside. And I just don't want that
- 20 interpretation to kind of get out of hand because I
- 21 don't think that was ever our intent. But I'll stop
- there and listen to other comments.
