The Court confirms the tentative ruling as follows:The Motion (ROA # 96) of Defendants Point Loma Patients Consumer Cooperative Corporation ("PLPCC"), Adam Knopf, Justus H. Henkes IV, 419 Consulting, Inc., Golden State Greens LLC, Far West Management LLC, Far West Operating LLC, and Far West Staffing LLC ("Defendants") for a protective order that confidential, private, privileged, and overbroad information not be produced and for an order restricting discovery of 1) PLPCC (i) Special Interrogatories, Set Two; (ii) Request for Production of Documents, Set Two; (iii) Request for Production of Documents, Set Three; (iv) Special Interrogatories, Set Three; 2) Far West Operating / Management / Staffing, Golden State Greens, and 419 Consulting: (I) Special Interrogatories, Set Two; (ii) Request for Production of Documents, Set Two; and 3) Adam Knopf and Justus Henkes: (i) Request for Production of Documents, Set Two; (ii) Request for Production of Documents, Set Two, is OFF CALENDAR IN PART, GRANTED IN PART and DENIED IN PART.

Defendants' Motion is, except as noted herein, DENIED.

Defendants' Motion to Plaintiff's Request for Production of Documents, Set One on all Defendants, is GRANTED.

Defendants' Motion to Plaintiff's Request for Production of Documents, Set Two on the entity defendants (PLPCC, Far West Operating, Far West Management, Far West Staffing, Golden State Greens, and 419 Consulting), is OFF CALENDAR as requested by Plaintiff. ROA # 154.

Plaintiff's request for sanctions is DENIED. Defendant has not acted without substantial ,justification.
