My name is Amy Sherlock and I came to your office on Wednesday, February 5, with a request for documents and I have not gotten a response. My late husband was awarded a CUP for a marijuana dispensary at 8863 Balboa Ave, San Diego in 2015. His name was Michael Sherlock and he passed away in December of 2015. Somehow the CUP was transfer or awarded to someone else in April of 2016, without my knowledge or consent. I've requested the documents on how this transfer occurred from Edith Gutierrez and Michelle Sokolowski over the past few weeks. Ms. Gutierrez has given me the run around to three different places where these documents are, which still have not been produced. Ms. Sokolowski refused to speak to me and gave me the City Attorney's contact information. I came to your office on February 5 to get some help regarding my situation and the lack of cooperation among the DSD personnel. The lack of response is quite concerning to me. Could someone please explain to me what is going on or how I can obtain the records I've requested?
