

**CITY OF SAN DIEGO MASTER PUBLIC RECORDS ACT STEERING DOCUMENT**

The City of San Diego (the “City”) is committed to transparency and providing easy access to public records pursuant to the California Public Records Act (CPRA). The California [Public Records Act](#) gives the public the right to access records created and maintained by public agencies in the course of their normal business. A PRA can be requested and tracked through the City of San Diego website portal at [Public Records Act Request](#) with specific PRA’s on file when you enter the [search portal](#).

The following list is comprised of PRA’s that have been acquired which pertain to the City’s Adult-Use of Cannabis (“Adult-Use”) laws and regulations which the City has responded to in areas specific to Adult-Use and fall under what we have collectively termed; OPERATION CANNA-GREED.

Each PRA in this Master PRA Steering Document (“Steering Doc”) will include a brief description of what the PRA will address with a hyperlink to that PRA. Some of these PRA’s are quite large so once in the PRA there will be a CONTENT Section which provides a breakdown of what we consider significant statements, emails, texts or data that warrant our comments. Those comments will always be in italics. The original request and the City’s response documents will follow. Where a response has not yet been provided, the PRA will link to the request with future updates to this Steering Document showing the response with Bates Numbers in red at the bottom of the pages to show the request and response have been completed.

*It's clear from these communication that on June 6, 2018, [Ricardo Ramos](#), City of San Diego, Deputy Director Business Tax Manager communicated to [Michelle Sokolowski](#) that certain licensees were "disputing the request" to provide financial data. (See Pg. 005 -006)*

*Of note, Michelle Sokolowski and Edith Gutierrez gave Amy Sherlock, Darryl Cotton and attorney Andrew Flores the run around when they met with a visibly upset Sokolowski on February 5, 2020, and requested information from the City as to how the 8863 Balboa CUP, which Michael "Biker" Sherlock had acquired, prior to his death, was transferred around his widow, Amy Sherlock without her knowledge or consent. *Keeping in mind this project was also located in a [HUD "Promise Zone"](#) (See Pg's. 094-100, 136), no CEQA was required (See Pg. 059 & 108-109) despite extensive renovation and it backs up to a river bed (See Pg. 059), DSD staff recommended it not be approved (See Pg. 097) because of sensitive use setback issues (See Pg. 121) and this "What about the ordinance???" email from Marsha Lyon, City of San Diego Sr. Prevention Specialist (See Pg. 017) the project was still approved for the applicant, Aaron Magagna, a Gina Austin and Marcela Escobar-Eck client.*

*Alan Austin, the project architect, states during the project review, they are exempt from having to do a Bulletin 580 review as there are no exterior changes. Development Project Manager Jeffrey Peterson replies that the historical photos of the building and the previous building plans the building HAS had exterior work done to it . He references the "approximately 12 ventilation systems have been mounted on the side of the wall are just some of the things that can be seen." What Peterson did not know was that those were not ventilation systems but were instead the exterior mounted condensing units that were maintaining optimal indoor cannabis cultivation temperatures in an operation that had not yet been City approved yet we in full swing cannabis cultivation operation. *On 11/25/2015, Brad Harcourt represents to the City that he is the Co-Founder and President of Full Circle Enterprises, Inc. (“FCE-8738” See Pg. 092) That is not true. The SOS filings for this entity can be seen that Harcourt was a member in FCE-8738 not the President and was dissolved on 12/02/2015 the day Biker supposedly, as in committed suicide. The timing of the communications with the City coupled with the purposeful intent by Harcourt and others, to deprive Amy of her beneficial rights to the CUP and the property cannot be ignored by this exchange. *On 01/10/2017, Harcourt sends an email to Tirandazi and Glenn with CC to attorney Ross Goodman and others that as a result of Biker’s death the 8863 CUP “would not be going to Austin’s new client cooperative,” Ninus Malan. (See Pg. 072)*

*The response was one page, and it did not address the Sherlock to Harcourt transfer at all, instead it provided the 5/24/2021 transfer into the receiver, Michael Essary’s name.*

22-4976 Amy Sherlock’s request for all record of the CUP submission and approval process at 8863 Balboa Ave. Ste. E from 2015 to present (2022)

*What distinguishes this City response from others is just how little documentation they provided Amy in their response to her request.*

Amy Sherlock's request for attorney Robert Otilie's letter to the Planning Commission regarding a Planning Commission Hearing held on December 15, 2016. Otilie describes what he sees as a Planning Commissioner, Anthony Wagner who has taken on the role of expert witness, providing expert testimony as an advocate, witness and a judge in a liquor license approval.

*As can be seen in their response, the City did not provide the requested letters as they are "not maintained in electronic format." (See Pg. 001-002) The December 13, 2016, letter addressed to Commissioner Wagner and a follow up December 14, 2015 letter to Stephen Haase, Chair have been acquired and are included in the link.*

*Otilie describes conduct Commissioner Wagner had engaged in his decision making process whereby he, "qualified yourself as an expert witness, provided what you contended was expert testimony, and then based your decision to grant a liquor license on your own expert testimony. It was a first. I have never heard of that in 39 years as a lawyer." (See Pg. 003)*

*Otilie describes the Planning Commission process as a Quasi-Judicial Proceeding in which a Commissioner is "Essentially a Judge." He cites Matthews v. Eldridge (1976) U.S. 319,331 the United States Supreme Court decision in which, "The federal Due Process Clause imposes constraints on governmental decisions that deprive individuals of 'liberty' or 'property' interests within the meaning of the Due Process Clause of the Fifth and Fourteenth Amendments." (See Pg. 004)*

*What Otilie describes in his letters what has been a bias by the Planning Commission in approving certain licenses (i.e. liquor or adult-use cannabis) when it is not in the public's best interest to do so or, as can be supported by mounting evidence, those in government who would consider and ultimately approve these licenses have a personal financial interest in doing so.*

*What follows is a breakdown of publicly available documents that show what Mr. Otilie had predicted in 2016 can be seen to have taken hold by those in public office who, through direct contributions, through the use of consultancy groups they had an interest in and through marriage, took large sums of money which could be used to sway matters into certain parties favors.*

Unidentified party requests communications City Staff to include Monica Montgomery-Steppe, Henry Foster, Lara Gates, Elyse Lowe with cannabis companies, lobbyists, consultants and lobbyists in San Diego to include Terrie Best, Armand King, Duane Alexander, Emma Johnson, Johann Balbuena, Christopher Lefall, Adrian Gonzales, Staci McClanahan Dent, Michael Polite, Spencer Andrews, Breton Peace, Gina Austin, Anthony Avalos, Miklos Campuzano, Aaron Magagna, Doug McCrady, Jessica McElfresh, Daniel Meier, Mathew Nathaniel, Phil Rath, Arkan Somo, Andrea St. Julian, Tak Soto, Matt Yaghagan, Sammi Ma, Jay Bowser, and Leroy Brady.

*This is an extensive, 1500 page look at what somebody who had an interest in exposing the inner workings of how the adult-use licensing scheme worked in the City and who were the players involved. Just asking for this information proves they knew there was smoke. They wanted to see where smoke would lead to the fire. Since this is such a large and complex response, we devoted an introduction to the PRA which will provide highlights and comments to the PRA.*

*As with PRA 23-4836 the City does not have records to fulfill this request.*

*What is remarkable here is that the City has NO responsive documents to this request even though Gutierrez acknowledges in email communications with Steve Lake she is seeking legal counsel from a "management analyst" on what documents are necessary to transfer the CUP away from Biker. (See Exhibit B2)*

Unidentified party request for all CITY OF SAN DIEGO vs. XTRACTA DISTRIBUTION, INC., et al, Case No. 37-2022-00020499-CU-CL-CTL (Complaint) a Dismissal with Prejudice and in support of this PRA, a referral to other instances of uncollected Cannabis Business Tax revenues which, in the December 18, 2024 GJC describe a wider pattern of these cases occurring within the City.

- As can be seen by this PRA response, when compared to the PRA 24-5099 response, the City, specifically Ricardo Ramos of the City Treasurers office, was curiously unwilling to provide Cotton with the information they provided to the party in the PRA 24-5099 response.*
