[PROPOSED] ORDER GRANTING
TEMPORARY RESTRAINING ORDER

1 IT IS ORDERED that defendants in the above entitled action shall appear in Department 75 of
2 this Court, located at 330 W. Broadway, San Diego California, 92101, on _____, at _____, or as
3 soon thereafter as the matter may be heard, to show cause why defendants Allied Spectrum, Inc.
4 (“Allied”), Prodigious Collectives, LLC (“Prodigious”), and the Austin Legal Group, APC (“ALG”),
5 and their respective agents and representatives, should not be enjoined and restrained during the
6 pendency of this action from engaging in, committing, or performing, directly or indirectly, any and all
7 of the following acts:

8 Defendant ALG shall not submit to any government agency any petitions for the application
9 and/or maintaining of cannabis permits or licenses on behalf of individuals who are not disclosed in said
10 submissions and are required by law to be disclosed.

11 Defendants Allied and Prodigious are enjoined from transferring, selling and/or encumbering
12 the Balboa Property and/or the Balboa CUP.

13 IT IS FURTHER ORDERED that, pending the hearing and determination of the Order to Show
14 Cause, that:

15 Defendant ALG shall not submit to any government agency any petitions for the application
16 and/or maintaining of cannabis permits or licenses on behalf of individuals who are not disclosed in said
17 submissions and are required by law to be disclosed.

18 Defendants Allied and Prodigious are enjoined from transferring, selling and/or encumbering
19 the Balboa Property and/or the Balboa CUP.
