


1 On Friday, December 2, 2022, at 9:00 a.m., in Department C-75 of the Superior Court of
2 California, County of San Diego, Central Division, located at the Hall of Justice, 330 West
3 Broadway, San Diego, California 92101, the Court, the Honorable James A. Mangione, presiding,
4 after considering all the evidence and arguments of counsel, granted the special motion by Defendant
5 ABHAY SCHWEITZER, individually and doing business as TECHNE ("Defendant"), pursuant to
6 Civil Procedure section 425.16 (Anti-SLAPP), to strike the First Amended Complaint, and all causes


