

# PRESS RELEASE

May 14, 2024 (Amended May 17<sup>th</sup>)

Amy Sherlock is the widow of Michael “Biker” Sherlock. Biker was a local San Diego sports hero having developed the X Games and street luge racing for a worldwide audience. Biker’s death in December 2015, originally ruled a suicide, is now being investigated as a murder by the very “partners” who were helping Biker realize his other dream in life, owning and operating an adult-use cannabis licensed dispensary in the City of San Diego. Sadly, it is a direct result of that dream, Biker was lured to his final fate, late at night on that dark and lonely La Jolla beach he had so loved in life.



On May 31, 2024, at 9:00 am, in courtroom C-75, Judge Mangione will be considering Mrs. Sherlock’s Motion to Vacate a civil action against, amongst others, local San Diego attorney Gina Austin. Mrs. Austin has been the leading cannabis license attorney in San Diego for many years. The reason this hearing is so important is because Mrs. Sherlock has, since 2021, been in litigation against a number of defendants, Mrs. Austin included, to expose the fraud being perpetrated upon the courts and the clear and evident, pay-to-play corruption that exists in adult-use cannabis licensing within the City of San Diego Development Services Department\*. An issue that has far-reaching consequences well beyond Mrs. Sherlock’s case.
