

1 1. On August 12, 2022, after full briefing and oral argument, this Court granted
2 Defendants GINA M. AUSTIN and AUSTIN LEGAL GROUP's ("Defendants") special motion
3 to strike pursuant to Code of Civil Procedure section 425.16 ("anti-SLAPP").

4 2. On January 30, 2023, this Court issued a Revised Judgment in favor of Defendants
5 against Plaintiffs Amy Sherlock, an individual and on behalf of her minor children, T.S. and S.S.
6 and Andrew Flores, jointly and severally, after the anti-SLAPP Motion was granted, awarding
7 attorneys' fees and costs in the amount of ~~\$27,727.50~~ ^{\$ 26,727.50} and interest on that amount at a rate of ten
8 percent (10%) per year from the date of the entry of judgment until paid in full. A copy of the
9 Revised Judgment is attached as Exhibit A.

10 3. To date, the judgment has not been paid. As of May 14, 2024, the interest is
11 \$3,441.62 on that judgment and it continues to accrue interest.

12 4. On August 16, 2022, Plaintiffs filed a Notice of Appeal from the Court's ruling
13 granting Defendants' anti-SLAPP Motion.

14 5. On September 18, 2023, after full briefing and oral argument, the Court of Appeal
15 affirmed this Court's anti-SLAPP ruling and awarded Defendants costs on appeal.

16 6. On January 8, 2024, Defendants filed their Motion for Attorneys' Fees in relation
17 to the appellate fees. Plaintiffs did not file an Opposition, and on April 11, 2024, this Court
18 awarded Defendants \$20,558.50, for further attorneys' fees, to be paid within 60 days, plus
19 interest on that amount at a rate of ten percent (10%) per year from the date of entry of judgment
20 until paid in full. Attached as Exhibit B is the Notice of Ruling.

21 THEREFORE, IT IS ORDERED, ADJUDGED, AND DECREED HAT:

22 7. Plaintiff's Complaint is stricken in its entirety as to Defendants, and this action is
23 dismissed as to Defendants.

24 8. Defendants are entitled to a judgment in their favor against Plaintiffs, and
25 Plaintiffs shall take nothing by way of their Complaint against Defendants; and

9. Defendants shall recover, from Plaintiffs, their reasonable attorneys' fees and costs in the amount of ~~\$51,727.62~~ ^{\$50,727.62}. This amount consists of the following:

- ~~\$27,727.50~~ ^{\$26,727.50} from the Court's January 23, 2023 Revised Judgment granting Defendants attorneys' fees.
- \$3441.62 on unpaid interest on the January 23, 2023 award of attorneys' fees.
- \$20,550.50 from the Court's April 11, 2024 ruling granting Defendants attorneys' fees on appeal.

10. Defendants shall recover interest on the principal amount of ~~\$51,727.62~~ ^{\$50,727.62} remaining unsatisfied, at the rate of ten percent (10%) per year from the date of entry of this judgment until paid in full.
