



Fwd: Amy Sherlock's request the cause of death of Michael "Biker" Sherlock be reopened for investigation. Case #15052054

Sergeant Tien,

Third times a charm! I finally figured out why my hyperlinks weren't working. Forgive the multiple emails (this is the final version) but I had to make sure you had everything to support my contention that further investigation into my husband's death is supported by the evidence in these two links. Please disregard the past two versions of this email.

As you can imagine I was shocked and disappointed by your 04/27/2023 call to me in which, despite the fact you stated there was "tons of motivation behind Biker's death," that you will not be pursuing any sort of investigation and no evidence will even be attempted to be collected by the police department. Furthermore, you said that the only evidence considered in determining this decision was the evidence that I supplied. As you know, motive, the conflicting physical evidence, and my statements of concern that Biker being in the cannabis industry would put him at high risk for foul play were not considered or documented in the field report. These large gaps, coupled with the medical examiners post-mortem autopsy which had its own issues, I found it necessary to hire an independent private investigator. In his overall analysis he included motives for murder, the independent medical examiners report and the police report. He concluded that there is enough evidence to cast doubt on the medical examiner's determination that Biker's died by suicide. Furthermore, a signature analysis which determined that Biker's signature on corporate dissolutions, submitted to the State of California, **18 days after his death, were forged**. Although I've reported the felony forgery to multiple law enforcement agencies and officers nobody will even write a report or investigate these forgeries that resulted in the theft of millions of dollars **and** is a direct motive for those who benefited by Biker's death. All of this information is

contained in the Armorous Report and has been included as a link to this communication.

I must admit I'm mystified how on the one hand you can tell me that there exists "tons of motivation behind Biker's death" and then on the other hand tell me you are of the professional opinion that the information I provided you during my 12/02/2022 meeting does not merit any kind or renewed interest in exploring what could easily erase the original conclusion of suicide to that of "undetermined" that would, in the opinion of my experts, be a more accurate determination by you, SDPD, the Medical Examiner and the City of San Diego.

As you can see, I've cc'd this email to include the Mayor's Office, the City Attorney, and the Chief of Police in the hope that, upon further consideration, you reconsider my request that the events surrounding Biker's death warrants a relook by the City of San Diego. Ultimately that relook, if you stand by the original reports, should include an updated written report that determines what those findings reveal to support the original conclusions or would lead to criminal complaints if it can be found that these criminal activities took place leading to prosecution for having committed these crimes. I don't feel I'm being unreasonable here, but I am flexible and willing to bend to the amount of time that has transpired realizing how difficult it must be to file criminal complaints with the passage of time. Accordingly, I would be willing to accept that the cause of death be changed, as per my experts opinion, to "undetermined."

In closing, there is currently civil litigation taking place with numerous parties that would have had the motivation and would have benefitted from Biker's death. I don't want to conflate any of the civil litigation with what would be necessary for you to support my efforts to see Biker's death be changed to undetermined. I would however ask you to consider the chronology of events that began with Biker acquiring an adult-use cannabis license under a Conditional Use Permit (CUP) and how this CUP ended up being put in my name after Biker's death by Development Services Department (DSD), while also putting it in Biker's business partners name, Brad Harcourt and finally into Ninus Malan's name. This might all sound confusing, so I break it down, with the multiple permit numbers this was done under on pages 3-4 of my Steering Document and on page 1 which requires that those who had the motive to murder my husband and used him as a strawman applicant did not disclose themselves in the adult-use cannabis license application process as required in California Code of Regulations § § 15003, 15004 and 15024.

I would ask you to reconsider opening the investigation up to, at a minimum, allow me to set the record straight. The evidence I've provided suggests that Biker may not have committed suicide. A ruling of undetermined would fairly and accurately clear that stain to my late husband's name. It's something that I, Biker, our sons, family and friends deserve.

Please respond to my email by close of business on May 10, 2023. If I fail to hear from you and the other recipients, I will be left to believe that whatever conspiracy that I may have believed existed could, in fact, be a reality. An unfortunate reality that would require further action on my part to fully expose these matters in a court of law.
